# **GRANULAR SOIL WETTING AGENT**

# **FIRST AID**

**If in Eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses if present, after the first 5 minutes, then continue rinsing eye.

# Aqua Fixx DG

- Reduces problems associated with localized dry spot (LDS) from hydrophobic soils in turfgrass.
- Is a nonionic wetting agent, made to remain effective in the soil for up to 6 months.
- Improves the rate and depth of water infiltration and helps minimize irrigation requirements.
- Can be applied as a season-long, residual wetting agent to reduce turf stress. It can be applied to all turfgrass areas, including golf course tees, fairways, athletic fields, lawns, sod farms, and any other general use turfgrass areas.
- Can also be used on newly seeded or hydro-seeded turfgrass or where planting ornamental trees, shrubs or flowers to reduce irrigation needs.

# **APPLICATION RATES**

Use Rates per 1000 sq. ft. Initial: 4 - 6 lbs.

Reapplication Interval

**Subsequent:** 2.5 - 3.5 lbs.

\*Estimated interval! Interval will vary due to environmental conditions. Watch for signs of plant stress such as browning or wilting and apply as needed. Application before signs of stress appear is preferred.

Use of the high rate allows fewer applications. Use the low rate for a more even soil moisture profile.

#### **APPLICATION TECHNIQUES**

Apply Aqua Fixx DG using conventional fertilizer spreading equipment. Water in immediately following application. For best results, apply Aqua Fixx DG early in the growing season. Applications can also be made "as needed" throughout the season to relieve plant stress caused by hydrophobic soils.

#### TURFGRASS Apply to dry turf only.

Follow applications with a full cycle of irrigation within 24 hours, to release Aqua Fixx DG from the carrier into the root zone.

## LANDSCAPE ORNAMENTALS Apply to dry foliage only.

Apply Aqua Fixx DG according to the application rates listed and follow with a full cycle of irrigation within 24 hours. For soil treatment of blooming plants, follow applications with a full cycle of irrigation within 6 hours to release dry material caught in the foliage into the soil surface.

#### **SPREADER SETTINGS**

Before spreading Aqua Fixx DG, it is recommended that calibration of your spreader be performed. Results may vary depending on equipment. There are a diverse number of and models that apply product at various rates and patterns. It is strongly recommended that spread pattern and delivery rate be monitored throughout application and recalibrated regularly.spreaders.

#### STORAGE AND DISPOSAL

**Storage:** Keep bags closed at all times. Store materials in a cool, dry area, away from oxidizing agents. Do not add anything to the container. Keep container tightly sealed when not in use. Do not store near fire, flame or other potential sources of ignition. Do not contaminate water, food or feed by storage or disposal of this product.

**Disposal:** Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading.
